## REGULATIONS

- All applicants must complete the application, and submit the fee of \$100.00 per day. The fee is non-refundable should the vendor be unable to attend the event. Within 10 days after the event, \$50.00 of the application fee will be returned to the vendor if the vendor stays until the end of the event.
- The vendor fee includes admission passes for four people. All other helpers, employees, volunteers, etc., will be required to pay the spectator entrance fee.
- Vendors are responsible for collection and payment of Idaho State sales tax. Vendors will be provided a form to be completed.
- Food Vendors are responsible for any and all state or local fees and requirements for food permits. Contact Southwest District Health for information at 208-549-2370.
- Site will be open Friday from 5:00pm to 8:00pm for set up . Set up MUST be completed by 9:00am on Saturday.
- Vendor vehicles must be moved to designated parking areas by 9:00am Saturday
- Vendor is responsible for the security of their booth at all times.
- Vendors are responsible for making sure their booth space is clean and clear of all debris after the event.
- The Weiser Chamber and the City of Weiser are not responsible for any damage, theft, loss or injury, etc.
